ADDITIONAL ITEMS:

Apartments, condominiums, mobile home parks individually metered shall be billed in accordance with the above schedule per unit.

When MUC is required to add pipe-work to accommodate the connection, the actual cost of said construction shall be added to the above fee.

If Morristown Utilities Commission discontinues water service for non-payment of bill or any other reason, and the water is turned on without authority of MUC, the utilities shall have the right to discontinue service, remove or lock out the meter, and charge for costs incurred in discontinuing service, plus the cost of a replacement meter, if required.
